Treasury Report: Proactive Release of Budget 2009 Documents

Executive Summary

The purpose of this report is to seek your view on whether you want to continue with the proactive release of Budget-related documents.

Treasury, with the approval of the previous Minister of Finance, has proactively released Budget-related documents for the last three years. The release is made on the Treasury website. The material disclosed is guided by the provisions of the Official Information Act (OIA). Relevant Vote Ministers and their Offices are consulted on this release.

Prior to proactively releasing Budget documents, the previous Minister of Finance (and his Office) received numerous OIA requests. These requests normally spanned most Votes thereby affecting the majority of departments and Treasury Vote teams. These requests were dealt with in an ad-hoc manner, which were individually time consuming and the responses were inconsistent, often requiring further clarification.

The material for release is processed by Treasury Vote teams to remove any information that would normally be withheld under the OIA. Deleted information generally covers issues of commercial sensitivity, free and frank advice and issues under active consideration, i.e. declined Budget bids. The modified material is then sent to your Office, who then co-ordinate with other Ministers' offices to ensure they are satisfied with the documents prior to releasing on the Treasury website.

Treasury considers that the proactive release of Budget documents has been quite successful in managing OIA requests for Budget-related material, reducing the time spent dealing with requests in both Ministers' offices and Treasury. In most cases, the information released has satisfied the needs of requestors.

Over the last three years, the release has been two to three weeks after Budget Day. Should you agree to continue with this practice, we suggest a release three weeks after Budget day, i.e. Thursday 18 June 2009. We consider that three weeks provides enough time to process all the recommended release material.

We suggest you write to your Ministerial colleagues outlining your decision to release Budget 2009 related material; and detailing what actions they and their Offices need to carry out. We have attached a draft letter for you to consider. Should you agree to this letter, the Treasury can prepare and send these letters to Ministers.

Below is a broad range of the types of documents we recommend releasing. Annex A provides a complete list of suggested papers to release.

Papers recommended to be released

We suggest releasing similar types of papers as in previous years, namely:

- Budget Policy Statement considered at Cabinet on 8 December 2008;
- 2. Cabinet minutes from the Budget Policy Statement;
- 3. Budget Briefings for Support Parties;

- 4. Letters to Ministers who you did not meet with;
- 5. Paper for the first Senior Executives Group meeting on 11 February 2009;
- 6. Paper for the second Senior Executives Group meeting on 17 February 2009;
- 7. Paper for the third Senior Executives Group meeting on 27 February 2009;
- 8. Paper for the first Budget Ministers' meeting on 9 March 2009;
- 9. Paper for the second Budget Ministers' meeting on 30 March 2009;
- 10. Bilateral briefings;
- 11. Budget package Cabinet paper considered by the Cabinet Strategy Committee on 6 April (including Cabinet minute);
- 12. Budget package Cabinet paper considered by Cabinet on Monday 20 April; and
- 13. All Cabinet Minutes associated with the above (these are currently being developed by the Cabinet Office and they will be sent to your Office once they are completed).

Copies of all these documents except the Cabinet minutes related to the Budget package are attached for your consideration.

- a **note** that the previous years' release of Budget material onto the Treasury website has been successful in reducing the time spent on subsequent OIA requests;
- b **agree** to release Budget 2009 material on the Treasury website on 18 June (three weeks after Budget day);
