# Cabinet paper - Taxation (Budget Tax Measures) Bill - approval for introduction

Attached to this report is a submission to Cabinet for consideration on 25 May. The submission seeks approval for the introduction of the Taxation (Budget Tax Measures) Bill on 28 May. The submission is to be made directly to Cabinet because no meeting of the Cabinet Legislation Committee is scheduled for the week beginning 18 May.

The contents of the proposed bill comprise the following:

- repeal of the final two tranches of the personal tax cuts enacted in December 2008 with effect from 1 April 2010 and 1 April 2011;
- repeal of the increase from 1 April 2010 in the amount of the weekly independent earner tax credit, also enacted in December 2008; and
- closure of the KiwiSaver mortgage diversion facility to new participants from 1 June 2009.

In addition, the submission seeks Cabinet's noting of the fiscal implications of these measures, consequential to the decisions in CAB Min (09) 12/9.

The Ministry of Justice has reviewed the proposed bill for consistency with the New Zealand Bill of Rights Act 1999 and considers the bill appears to be consistent with that Act.
