**AIDE MEMOIRE: CONFIRMATION OF AGENCY CONTRIBUTIONS TO FUNDING OF THE NEW ZEALAND PRODUCTIVITY COMMISSION**

In Cabinet's recent decision to establish a New Zealand Productivity Commission, the funding contributions of departments and Crown entities were set out in a table [CAB Min (10) 7/12 refers]. It was noted, however, that the funding provided by certain agencies was still being negotiated, and that you and the relevant Vote Ministers had authority to determine the amounts. The funding level from those agencies has since been agreed.

This Aide Memoire sets out the final levels of agency contributions in the attached table. This note is for your information: no decisions are required.
