## Treasury Report: Shares Plus Consultation: Logistics

---

1. This report sets out the arrangements for the shares plus consultation hui over the next two weeks.

### Who we are consulting with

2. The government has chosen to undertake targeted consultation, which involves face to face meetings with those groups who have interests in water or geothermal resources that are directly affected by the operations of one or more of Genesis Energy, Mighty River Power and Meridian Energy (T2012/2202).
3. The main principle for organising the hui has been to cluster iwi into related groups and to hold the hui in places that are accessible to all of the participants. One extra hui was proposed specifically for Maniapoto in Te Kuiti as you were already meeting with them, under their river accord, during the consultation period. Raukawa were also invited to this hui (as an alternative to Hamilton at their election) on the basis that it might be more convenient for them.

4. Te Puni Kokiri has used its regional offices to work with these groups and agree appropriate venues.

5. Some issues have arisen with the choice of locations and venues:
  - The decision to hold hui in both Hamilton and Te Kuiti has confused some iwi, but we believe any issues have been resolved. The Chair of Ngāti Maniapoto – Tiwha Bell – has asked to attend the Hamilton hui as well as the Te Kuiti hui.
  - Raukawa would have preferred their own hui, and have asked to attend both the Hamilton and Taupo hui.
  - Ngāti Koroki Kahukura would have preferred the Hamilton venue to be located closer to the Waikato River, and initially refused to attend. They have now proposed attending the Taupo hui instead.
6. Officials have worked closely with these groups to accommodate such issues while ensuring the concept of clustering is maintained.

### Departmental and cultural support

7. Chris White (Treasury) and Paul Radich (Crown Law Office) will attend each hui, as will a senior representative and note-takers from Te Puni Kokiri (TPK). Hemana Eruera (TPK) will be present at each hui to provide cultural support and translation if required.

### Local participation

8. TPK have organised for local Co-Chairs to assist in the running of each hui. TPK Regional Directors will also be present. The TPK Regional Director will be present at each venue thirty minutes before the starting time to provide a briefing on local issues to Minister(s) and officials, if required.
