Solid Energy Corporate Office

I want to alert you to some earthquake related changes Solid Energy is making to accommodate our staff.

Solid Energy has made and will stand by our commitment to Christchurch as our Corporate Office and to support the rebuild of the city in the coming years. The series of earthquakes has, however, impacted the ability of the business to meet some of its ambitious business objectives. It has become significantly more challenging to attract skilled New Zealand and international employees to grow the business in Christchurch.

There are also real concerns around retaining existing staff. Employees without emotional and family ties to Christchurch are very mobile in a relatively buoyant Australasian job market and there is a risk that turnover will increase and that the business won't be able to back-fill these roles within a reasonable timeframe.

During a downturn, these risks may have been manageable, but with the business moving through the MOM process, delivering on our business plans is critical during this time. Ultimately, a growing business can also support the rebuild in Christchurch far more effectively.

We have had to consider some creative solutions during these interesting times. One of the solutions we have implemented is to relocate some staff in our Finance, Procurement and New Developments teams to a small office in Greenlane, Auckland on a three-year lease. In addition we have recently acquired office space in Nelson, also on a three-year lease. The Nelson office gives us a location option, over and above Christchurch, in recruiting technical staff to work in the business supporting our West Coast operations. While our plans for this office predate the Canterbury earthquakes, the rationale has become even more compelling since February 2011.

We regard these steps as positive, proactive measures to help our company remain strong, with our headquarters in Christchurch.
