2 Housing Infrastructure Fund to Support Housing Development in High-Growth Urban Areas

This paper seeks Cabinet agreement to create a one-off housing infrastructure fund. Councils in high-growth urban areas could apply to this fund for short-medium term financing to bring forward infrastructure for housing development, with repayment being made over time or as development occurs.

The fiscal implication of the \$1 billion fund will depend on the detailed design of the funding mechanism and the nature of the projects funded. These are not known yet.

The administration of the fund will be undertaken by MBIE. Additional funding will be sought in the next reportback in August.

Support in principle subject to detailed design parameters being agreed by Cabinet after considering feedback from local Councils.

We recommend any announcement should indicate that Cabinet is considering a proposal and seeking feedback from Councils.

There are numerous risks set out in the paper including raising expectations for further Government support from councils facing other infrastructure challenges (e.g. tourism), and risks that financing is not the main constraint so the initiative may not release significant amounts of housing.
