Budget 2013: Vote Justice Technical Initiatives

On 8 April 2013, Cabinet:

- approved the technical initiatives for the above Vote for inclusion in the 2013 Budget package, as detailed in the attached initiative documents;
- approved the changes to appropriations and projected balances of net assets of the administering department to implement the technical initiatives, as set out in the attached initiative documents;
- approved the additional recommendations to give effect to the technical initiatives, as set out in the attached initiative documents;
- 4 **agreed** that the changes to appropriations and projected balances of net assets for 2012/13 be included in the 2012/13 Supplementary Estimates and that, in the interim, the increases be met from Imprest Supply;
- authorised the Minister of Finance and the Vote Minister to approve jointly any technical adjustments to baselines necessary to remove any errors or inconsistencies identified while finalising the 2012/13 Supplementary Estimates, the 2013/14 Estimates and the fiscal forecasts;
- authorised the chief executives of departments that monitor Crown entities directly affected by decisions in this minute to inform the chair and/or chief executive of a Crown entity, on a budget-in-confidence-until-budget-day basis, of decisions that directly affect that Crown entity for the purpose of planning and preparation of their Statement of Intent;
- noted that all communications relating to the 2013 Budget are co-ordinated by a Budget communications committee, and that any requests for early announcement will need to have both the written approval of the Minister of Finance and sign-off from the Prime Minister's office.

- 8 **noted** that the figures in the appropriation table above show only the net changes to the Community Law Centres appropriation;
- noted that the Receipts from the Law Society's Special Fund for Community Law Centres is forecast [6] shown below and that the Law Centres appropriation has been receipts:

- noted that Joint Ministers have agreed \$6.600 million in 2013/14 and \$5.800 million in 2014/15 as a charge against the Justice Sector Fund tagged contingency for Community Law Centres;
- noted that Joint Ministers have agreed \$1.890 million in 2013/14 and \$2.530 million in 2014/15 as a charge against the Justice Sector Fund tagged contingency for the expansion of Restorative Justice programmes;
- **noted** that the Impairment of Offender Levy appropriation has been reduced to reflect updated forecasts;
- 13 **noted** that the net assets of the Ministry of Justice are increasing due to forecast movements in memorandum accounts;
- agreed to cease purchasing free wills from the Public Trust and to transfer the current funding to other priorities identified in the Justice Sector Four-year Plan in the Ministry of Justice;
- noted that there are a number of low-cost or free options already available for producing a will and that there are other mechanisms for addressing access to justice issues around wills that could be developed, if required.
