I am writing to seek your approval to a technical adjustment to baselines prior to the finalisation of the 2013/14 Estimates.

As part of Budget 2013, new funding of \$1 million in 2013/14 and outyears was appropriated for the establishment and implementation of a Māori language research agenda. The funding also included provision for capacity and capability development among the Māori language research community.

As the health of the Māori language remains fragile, increased research, development and innovation is required to support its revitalisation.

Accordingly, I seek your approval for a fiscally neutral transfer from Non-Departmental Output Expense: Rawa to Non-Departmental Other Expense: Māori Language Research of \$1 million in 2013/14 and outyears, to provide necessary momentum for the Māori Language Research Agenda to actively support gains in the overall health of the Māori language through increased research and development.

This funding will ensure that the research and development work can be applied to critical issues in real time. This will support our other investments in the Māori language sector, and provide further momentum for our efforts to support the revitalisation of the Māori language.

Recommendations

I recommend that you:
