Aide Memoire: Update on KiwiRail Work

This Aide Memoire provides a summary of the current work being undertaken by the Treasury and the Ministry of Transport in relation to KiwiRail, in particular its Budget Bid and repair work on its South Island network.

Budget Bid

- The Treasury has instructed KiwiRail that Ministers wish to see [34]
- KiwiRail has advised that it will provide these alternatives in time for the upcoming Investment Panel review of its Budget Bid. The Investment Panel review is scheduled for Wednesday, 1 March.

Earthquake Repair

- A Treasury Cabinet Paper has been prepared recommending [37]
- The Treasury and the Ministry of Transport are preparing process instructions for [37]

- The Investment Panel will review the "Earthquake Package: Transport Covering SH1 and KiwiRail" on Friday, 3 March.
- Officials from the Treasury, the Ministry of Transport and various Minister's offices are meeting KiwiRail on Thursday 23 February to receive an update on the earthquake rebuild, Midland Line fire and other matters.

Other Matters

- KiwiRail has indicated that a request for equity funding of [25] will be presented to Shareholding Ministers next week. This funding is part of Budget 2015 and the Crown's ongoing support for KiwiRail. It does not relate to the earthquake.
- A board appointment process is underway for two new board members to replace
 Dr Kevin Thompson and Rebecca Eele. Interviews are scheduled over the next
 two weeks with a view to new appointments commencing 1 May 2017 or sooner.
