- 3 **agreed** to ring-fence \$2.0 million of the NEETs tagged contingency for the 'Passports for Life' Māori Development initiative;
- 4 **noted** that initiatives will need to meet certain assessment criteria and conditions in order to get access to funding from both these contingencies and these will be approved by Cabinet in due course.
