The initiative would split each annual funding round between the development of new projects, and the replication of successful projects from existing rounds of the CPF into other regions or across the country. Approximately 60 projects per year would be delivered. It is not possible to determine the number of projects that would be supported in a given year, nor the number of communities and individuals that would be assisted by projects delivered under the CPF.

Additional Recommendations

noted that there are offsetting savings of \$2.000 million in Vote Health, \$2.000 million in Vote Education, \$1.100 million in Vote Social Development, \$0.400 million in Vote Child, Youth and Family Services and \$0.307 million in Vote Community and Voluntary Sector;

noted that final decisions around the allocation of existing resources in the Community Partnership Fund have already been taken, and that following these decisions a total of \$0.193 million of the original \$17.403 million multi-year appropriation remains unspent;

noted that adding this unspent portion to the new funding of \$5.807 million brings the total amount available for allocation from the extended Community Partnership Fund to \$6.000 million in 2008/09, with \$0.200 million allotted to administration of this scheme.
