Current Scope:

In addition to the routine or extraordinary maintenance of the two Government Houses and grounds, purchases of and investment in capital items to maintain or increase the overall value of the Crown's asset holding;

New Scope:

This appropriation is limited to renovation and conservation of the Government House, Wellington property to maintain or increase its on-going use, functionality, and value as a heritage asset; and purchases of and investment in capital items for the two Government Houses;

2.2 Departmental Output Expense: Support Services to the Governor-General and Maintenance of the Two Government Houses

Current Scope:

Financial, administrative, communications, travel and advisory services for the Governor-General; services to maintain the Governor-General's two residences including gardening, maintenance and security. The increase reflects additional funding for preliminary investigations for the Government House Wellington restoration project;

New scope:

This appropriation is limited to financial, administrative, communications, travel and advisory services for the Governor-General; services to maintain the Governor-General's two residences including gardening, maintenance and security; renovation and conservation of Government House, Wellington.
