## **Gifts and Hospitality Register**

## **General Principles:**

**Principle 1:** Treasury staff should not accept gifts or hospitality unless there is a clear business benefit to the Treasury that exceeds any private benefit.

**Principle 2:** Treasury staff must refuse all gifts or hospitality that could reasonably be seen or perceived as undermining the integrity of individual Treasury staff, the Treasury or the wider state sector.

Treasury policy is that offers of gifts are to be accepted only if refusal would cause offence or embarrassment, and that accepted gifts are not kept by the recipient for personal use or benefit.

## Notes:

All offers of gifts and hospitality were treated in accordance with Treasury's Gift and Hospitality Policy.

This register discloses all gifts and hospitality for amounts \$50 and above that were accepted between 1 July 2011 and 30 June 2012.

Where several staff accepted an invitation for the same hospitality, then the event is noted as a single entry in the register published below.

In total, 71 offers of gifts and hospitality were accepted. Offers of hospitality represented 88% by number, and 85% by value of all offers made.
