#### Part C1 - Departmental Output Expenses

#### National Maritime Co-ordination Centre

A new appropriation has been established for all National Maritime Co-ordination activities that were previously funded by eight government agencies.

Under this Output Class, the New Zealand Customs Service provides whole-of-government coordination services to maximise the efficient and effective use of Government's maritime patrol and surveillance assets, and related information, for civilian purposes. These services relate to New Zealand's sovereignty, safety, economic, environment and foreign policy interests in the maritime environment. The services are provided by the National Maritime Co-ordination Centre, an operationally independent unit within Customs.
