### What is structural policy reform ("behind-the border barriers")?


- Measures to improve market efficiency
- Relates both to institutions ("rules of the game" and policy institutions) and to transactions costs of doing business
- Priority areas identified by LAISR 2004



### How does SR support APEC's economic agenda?

- Progress in reducing border barriers (tariffs and trade facilitation), but barriers behind the border are still significant
- Trade, macro, and structural policies are mutually reinforcing for economic growth
- Policy coherence is important the example of Chile


### Three elements of APEC's economic agenda are reinforcing




#### International studies

- Higher compliance costs:
  - Static effects: Divert resources from productive uses
  - Dynamic effects: Reduce returns from investment
  - Reduce rate of firm entry and exit and contestability of markets
  - -Impedes regional integration

#### International studies

- Payoffs from regulatory reform:
  - Economies with better regulations grow faster.
  - Improving from worst quartile of business regulations to best implies a 2.3% increase in annual growth (World Bank, 2005).
  - Ongoing regulatory reform has improved productivity in developed economies.
  - Large payoff to unilateral regulatory reform in APEC (Dee, 2005)

# Cost of doing business and productivity



#### A Case study of reform: New Zealand


- Structural reforms resulted in improved economic performance in New Zealand.

- New Zealand's growth performance since the reforms.

# APEC is a good place to promote improved structural policies


- Forum for senior officials to discuss policy challenges, share experiences and good practices, and provide technical support where necessary
- Existing institutional structure
- Different stages of development of members lots of different experiences to share.
- Connection with business community via ABAC
- No one-size-fits-all approach

### Mandate and milestones: EC and APEC's structural reform agenda

- 2004: Leaders' Agenda to Implement Structural Reform (LAISR) 2004
- 2005: APEC Work Plan on LAISR towards 2010 (LAISR 2010)
- 2007: Forward Work Programme for LAISR
- 2008: Structural Reform Ministerial Meeting
- 2010: Stocktake of progress on structural reform including how it has contributed toward the Bogor Goals

# APEC is working to promote improved structural policies

- Economic Committee leads and coordinates APEC's structural reform agenda.
- Other APEC fora also involved eg, CPDG, SELI, IEG, FMP, SME-WG and other sectoral working groups
