Part 2 - Details and Expected Performance for Output Expenses

Part 2.1 - Departmental Output Expenses

Administration of Indigenous Forestry Provisions (M2)

Scope of Appropriation

Administration of the indigenous forestry provisions of the Forests Act 1949, with the purpose of promoting the sustainable forest management of indigenous forest land.

Reasons for Change in Appropriation

This appropriation will decrease by \$117,000 to \$2.064 million due to changes in cost allocations between output expenses.

Agriculture and Forestry Policy Advice (M2)

Scope of Appropriation

Policy advice in regard to the agricultural, forestry and horticultural sectors, and ministerial services.

Reasons for Change in Appropriation

This appropriation will decrease by \$790,000 to \$27.197 million for 2008/09 due mainly to an expense transfer to 2009/10 for sustainable land management.

Animal Welfare (M2)

Scope of Appropriation

Setting of animal welfare standards and investigations and prosecutions of breaches of the Animal Welfare Act 1999.

Reasons for Change in Appropriation

This appropriation will increase by \$267,000 to \$2.907 million due to an increase in animal welfare investigations and prosecutions.

Climate Change (M2)

Scope of Appropriation

Policy advice and implementation, operational costs and fulfilling international obligations to support the Government's commitment on climate change under the Kyoto Protocol.

Reasons for Change in Appropriation

This appropriation will decrease by \$5.632 million to \$37.752 million due mainly to expense transfers to 2009/10. Delays in progressing some areas of the climate change plan of action and the select committee review of the NZ Emissions Trading Scheme has meant some expenditure planned for 2008/09 will now be incurred in 2009/10.

Contract, Grant and Asset Management (M2)

Scope of Appropriation

Management of the Crown's ownership interest in forests established on Crown-Owned and leased Māori land. Management of the Sustainable Farming Fund, East Coast Forestry Project and flood relief programmes.

Reasons for Change in Appropriation

This appropriation will increase by \$251,000 to \$3.877 million due mainly to the transfer of Timberlands West Coast Limited forestry operations to Ministry of Agriculture and Forestry (MAF), with effect from 1 January 2009.

Support Services and Infrastructure to Other Agencies RDA (M2)

Scope of Appropriation

This appropriation is limited to the provision of support services to other agencies, including financial, personnel and information technology services and subleasing of surplus accommodation.

Reasons for Change in Appropriation

This appropriation will increase by \$1.655 million to \$11.255 million in 2008/09 to reflect current levels of support services being supplied to other agencies.

Part 2.2 - Non-Departmental Output Expenses

Management of Crown Forestry Assets (M2)

Scope of Appropriation

Payments for forest and asset management of Crown forests established on both Crown-Owned and leased Māori land and 13 leases of Crown-Owned land to other parties for forestry purposes.

Reasons for Change in Appropriation

The appropriation will increase by \$5.992 million to \$83.245 million mainly due to the transfer of Timberlands West Coast Limited forestry operations to MAF, with effect from 1 January 2009.

Part 5.2 - Non-Departmental Other Expenses

Adverse Climatic Events (M2)

Scope of Appropriation

Support to the agriculture and horticulture industries in the aftermath of adverse climatic events.

Reasons for Change in Appropriation

The appropriation will increase by \$100,000 to \$736,000 for 2008/09 due to the transfer of funding from 2007/08 to build rural capacity to respond to adverse events.

Afforestation Grants Scheme (M2)

Scope of Appropriation

Payment of grants under the Afforestation Grants Scheme.

Reasons for Change in Appropriation

This appropriation will decrease by \$3.600 million to \$1.400 million for 2008/09 due to grant payments being less than originally forecast.

Community Irrigation Fund (M2)

Scope of Appropriation

Payment of grants under the Community Irrigation Fund

Reasons for Change in Appropriation

This appropriation will increase by \$200,000 to \$443,000 for 2008/09 due to the broadening of the scope of the community irrigation fund. Total funding approved for the eight-year programme has not increased but the allocation between years has been revised.

East Coast Afforestation Grants (M2)

Scope of Appropriation

Grants to approved private forest growers under the Forestry (East Coast) Grants Regulations 1992.

Reasons for Change in Appropriation

This appropriation will decrease by \$6 million to \$2.803 million for 2008/09 due to grant payments being less than originally forecast.

New Zealand Walking Access Commission (M2)

Scope of Appropriation

This appropriation is limited to the operation of the New Zealand Walking Access Commission.
