Reasons for Change in Appropriation

A new multi-year appropriation for historical Treaty of Waitangi settlements is established each year in the Supplementary Estimates Act, and the balance of the previous multi-year appropriation is cancelled. The amount of the current multi-year appropriation 'Historical Treaty of Waitangi Settlements' is \$400 million over five years. The new multi-year appropriation 'Historical Treaty of Waitangi Settlements 2009 - 2013' (which will be in force from 30 June 2009) will have an amount of \$800 million over five years. The reason for the change is to ensure there is sufficient legal authority to finalise agreements in principle that were negotiated in 2008/09 and continue the momentum in Treaty settlements achieved in that year.
