##### *Reasons for Change in Appropriation*

This appropriation will decrease by \$3,000 due to the transfer of output costs to the communication interoperability project led by another Vote.

Managing procurement or refurbishment, on behalf of the Crown, of various items of equipment contributing to a capability of the New Zealand Defence Force.

*Reasons for Change in Appropriation*

The appropriation will increase by \$1.004 million which is due primarily to an additional \$1 million costs incurred in contract warranty issues and additional pre-acquisition costs of \$207,000 which has been incurred in the purchase of specialised military equipment, and a reduction of \$200,000 due to a fiscally neutral transfer to Policy Advice. The pre-acquisition costs are recovered from the New Zealand Defence Force.
