BUDGET MINISTERS MEETING – 16 MARCH 2010: RECORD OF DECISIONS

SUMMARY

The aggregation of all of the Baseline Alignment Proposals provides the basis for a Budget package that is consistent with the Government's fiscal strategy and comes within the allowance of \$1.1 billion of new operating spending. As it currently stands, Health (\$417 million of new spending), Education (\$300 million of new spending) and Justice (\$38 million of new spending) would be the major components of the Budget (excluding infrastructure initiatives).

For most Votes the BAPs do not propose significant reprioritisation options, and therefore with no new spending across these Votes, there will be little scope for substantive Budget announcements of new initiatives.

- Vote Economic Development: overspent by \$6.625 million in 2010/11 owing to proposed contributions from other Votes to establish a multi-year appropriation to 'leverage' off Rugby World Cup. The rest of the \$17.25 million for the proposed appropriation comes from transfers with the Vote and previous Cabinet decisions.
- Votes Environment and Climate Change: does not include a provision for the transfer of aquaculture funding to Vote Fisheries.
- Vote Fisheries: overspent by \$451,000 as a transfer for Aquaculture from Vote Environment and Climate change has not been included.
- Vote Labour: [information deleted in order to maintain the current constitutional conventions protecting the confidentiality of advice tendered by ministers and officials].
- Vote Land Information: overspent by \$607,000 in outyears. Extra funding for Treaty of Waitangi implementation costs, Geospatial work, Ministry for the Environment properties and policy resources are not offset by sufficient savings.
- Vote Research Science and Technology: currently underspent as BAP recommends that savings generated from another Vote should be used to fund Creative Commons as this initiative is expected to generate savings for many departments. If it cannot be funded from other votes it should be funded from within Vote State Services or Vote RS&T.
