Certain information in this document has been withheld under one or more of the following sections of the Official Information Act, as applicable:

- [10] 9(2)(j) - to enable the Crown to negotiate without disadvantage or prejudice
- [11] 9(2)(k) - to prevent the disclosure of official information for improper gain or improper advantage
- [12] Not in scope
- [13] 7(b) - to prevent prejudice to relations between any of the Governments of New Zealand, the Cook Islands or Niue
- [14] 9(2)(ba)(i) - to prevent prejudice to the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.

Where information has been withheld, a numbered reference to the applicable section of the Official Information Act has been made, as listed above. For example, an [4] appearing where information has been withheld in a release document refers to section 9(2)(b)(ii).

In preparing this Information Release, the Treasury has considered the public interest considerations in section 9(1) of the Official Information Act.

### Budget 2013: Technical Financial Recommendations

Portfolio: Finance

On 8 April 2013, Cabinet:

- 1 **agreed** to the technical budget initiatives for Budget 2013 as set out in the financial recommendations attached to the paper under CAB (13) 178;
- 2 **authorised** the Minister of Finance and relevant Vote Ministers to approve changes to technical initiatives and appropriations where this proves necessary to finalise the Budget 2013 package;
- 3 **noted** that all communications relating to Budget 2013 are coordinated by a Budget communications committee, and that any requests for early announcement will need to have both the written approval of the Minister of Finance and sign-off from the Prime Minister's Office;
- 4 **agreed** that until the Appropriation (2013/14) Estimate Bill is enacted, expenses or capital expenditure against appropriations set out in the 2013/14 Estimates and being sought in that Bill may be met from Imprest Supply.
