### Budget 2013: Vote Attorney-General Technical Initiative

On 8 April 2013, Cabinet:

- 1 **approved** the technical initiative for the above Vote for inclusion in the 2013 Budget package, as detailed in the attached initiative document;
- 2 **approved** the changes to appropriations to implement the technical initiative, as set out in the attached initiative document;
- 3 **approved** the additional recommendation to give effect to the technical initiative, as set out in the attached initiative document;
- 4 **agreed** that the changes to appropriations for 2012/13 be included in the 2012/13 Supplementary Estimates and that, in the interim, the increases be met from Imprest Supply;
- 5 **authorised** the Minister of Finance and the Vote Minister to approve jointly any technical adjustments to baselines necessary to remove any errors or inconsistencies identified while finalising the 2012/13 Supplementary Estimates, the 2013/14 Estimates and the fiscal forecasts;
- 6 **noted** that all communications relating to the 2013 Budget are co-ordinated by a Budget communications committee, and that any requests for early announcement will need to have both the written approval of the Minister of Finance and sign-off from the Prime Minister's office.
