MSD have just informed me that Work & Income have come to the realisation that not all of the community max sponsors need the full amount of the training and supervision money that was set aside for each trainee (hardly a surprise given how generously community max was funded per place). They expect to have a saving of \$3 million this calendar year which Minister Bennett intends to ask Cabinet for agreement to use for an increased numbers of places. At around \$13,000 per 6 month place this would work out at a little over 200 places, although if they do not have the full training and supervision component it might be a few more. Given this is using the same appropriation for the intended purpose we do not have the same concerns with the proposal as we do with the proposal to use the \$9 million dottar underspend from the 9 day fortnight that is covered below.

It is possible Minister Bennett may raise this as an oral item at Cabinet this morning, either asking for a decision or for SOC to have power to act. Too not know whether she will also raise the suggestion of using the 9 day fortnight underspend as well.

#### Hi Alex,

Just a heads-up: We understand Minister Bennett's Office may be in touch with you to test the possibility of transferring underspends from the Job Support Scheme (9 day fortnight) to the Employment Assistance appropriation (which pays for job subsidy type things including Job ops and community max).

The main issue here is that the Job Support Scheme underspends (which we still anticipate being in the realm of \$9m over two years) are "windfall" gains from uptake of the policy being less than expected, which according to the Budget rules confirmed by Cabinet are to be returned to the centre.

It is also hard to see why Employment Assistance would need more funding. At December actuals it was tracking slightly below forecast, and before the Job Ops and Community Max funding was put in, had been reduced several times to fund various other initiatives, always with MSD's assurance that it is fine.

Treasury does not support Community Max on the basis that it has no evidence of effectiveness, and costs more than any other employment intervention or training (at \$11,600 per participant for six months it costs almost twice as much as a typical wage subsidy or funded tertiary training position).  Treasury expressed this view in a comment in the consultation section of the paper. The Treasury comment was removed by the Office of the Minister for Social Development and Employment prior to lodging with Cabinet Office, in contravention of Cabinet guidelines	Raper to be considered by Cabinet on Monday 21 June	The Minister can table Treasury's comment (provided in your precab briefing) when the paper is considered by Cabinet.
