New Zealand Police Vehicle Fleet Replacement Programme: Proposed Capital Expenditure 2016/17 to 2019/20

Purpose

1. This paper provides an update on NZ Police's vehicle fleet replacement programme, and seeks approval to spend up to \$82 million of existing Police capital resources over the next four years to continue replacing vehicles.

Comment

- 2. Police has around 3,100 vehicles. Between 400 and 500 of these need to be replaced each year. Police funds the purchase of replacement vehicles with accumulated depreciation from previous vehicles.
- 3. While Police's vehicle replacement is a business-as-usual activity, Police periodically reports to Ministers seeking approval for a further tranche of vehicle replacements. This is because the rules around capital expenditure require Ministerial approval for investments greater than \$15 million, and Cabinet approval for investments greater than \$25 million [Cabinet Office Circular CO(15)5 refers].
- 4. Police has recently taken steps to reduce the cost and improve the efficiency of its vehicle fleet. These have led to a reduction in the proposed levels of capital expenditure for the next four years (\$20.5 million per year, as compared with \$24 million in the current year), and reduced operating costs. These steps include:
 - tendering the vehicle supply and fit-out contract as part of the Ministry of Business, Innovation and Employment's All-of-Government vehicle tender, which led to a price reduction:
 - increasing the use of smaller vehicles (e.g. 400 V6 Holden Commodores are being replaced with vehicles such as the Holden Cruze); and
 - < implementing a pool vehicle booking system to increase vehicle utilisation rates.
- 5. Police also investigated leasing rather than buying vehicles, but found that leasing its vehicles would be considerably more expensive than ownership.
- 6. In our view, Police is managing its vehicle fleet appropriately. We are comfortable with Police proceeding with the proposed capital expenditure.
- 7. This paper is not affected by the Budget moratorium because there are no impacts on appropriations or on forecasts.
