Key to sections of the Official Information Act 1982 under which information has been withheld.

Certain information in this document has been withheld under one or more of the following sections of the Official Information Act, as applicable:

- [1] 9(2)(a) - to protect the privacy of natural persons, including deceased people
- [2] 9(2)(f)(iv) - to maintain the current constitutional conventions protecting the confidentiality of advice tendered by ministers and officials
- [3] 9(2)(g)(i) - to maintain the effective conduct of public affairs through the free and frank expression of opinions
- [4] 9(2)(b)(ii) - to protect the commercial position of the person who supplied the information or who is the subject of the information
- [5] 9(2)(k) - to prevent the disclosure of official information for improper gain or improper advantage
- [6] 9(2)(j) - to enable the Crown to negotiate without disadvantage or prejudice
- [7] 6(a) - to prevent prejudice to the security or defence of New Zealand or the international relations of the government
- [8] 9(2)(h) - to maintain legal professional privilege
- [9] 6(c) - to prevent prejudice to the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial
- [10] 9(2)(d) - to avoid prejudice to the substantial economic interests of New Zealand
- [11] 9(2)(i) - to enable the Crown to carry out commercial activities without disadvantage or prejudice.

Where information has been withheld, a numbered reference to the applicable section of the Official Information Act has been made, as listed above. For example, an [8] appearing where information has been withheld in a release document refers to section 9(2)(h).

In preparing this Information Release, the Treasury has considered the public interest considerations in section 9(1) of the Official Information Act.

Dear Judith

I am writing to communicate my decisions on the final package for Budget 2011.

In early February you forwarded to me the resubmitted Four-year Budget Plans prepared by the Department of Corrections and New Zealand Police for Votes Corrections, Police and Serious Fraud as part of the preparation for Budget 2011.

Budget Ministers have met a number of times in the last few weeks to discuss specific proposals, how they fit in the overall Budget package and how we will meet the costs of the Canterbury earthquake.

Following those discussions, I have decided that the Four-year Budget Plans for Votes Corrections, Police and Serious Fraud should be accepted.

As you know, Cabinet agreed to the proposal for Support to Veterans' Homes at the meeting on 21 March, subject to suitable sources of funding being identified as part of the Budget package. Budget Ministers have agreed that if you wish to include this as part of Budget 2011 you should identify sources of funding for this proposal from within existing baselines.

Your department should complete financial recommendations as soon as possible to give effect to any agreed changes to appropriations. I intend to take the final Budget package to Cabinet at the start of April. Following that, estimates documents will be due in April.
