Overview of the Vote

The Attorney-General is responsible for appropriations in the Vote for the 2015/16 financial year covering the following:

- a total of just over \$22 million (34% of the Vote) for the provision of legal advice and representation services to central government departments and Crown agencies on a full cost-recovery basis
- a total of just over \$3 million (5% of the Vote) for providing legal advice, representation services and administrative services to the Attorney-General and Solicitor-General to assist them in the exercise of their Principal Law Officer functions, and with the provision of legal and constitutional advice to the Government, Ministers and the judiciary
- · a total of just under \$1 million (1% of the Vote) for departmental capital expenditure, and
- a total of just under \$39 million (60% of the Vote) for the supervision and conduct of Crown
 prosecutions and appeals. This covers: conducting appeals arising from Crown prosecutions; the
 provision of advice on criminal law, mutual assistance and extradition matters to other government
 agencies and Crown Solicitors; the oversight of public prosecutions and supervision of the network of
 Crown Solicitors who deliver prosecution services, and the provision of a national Crown prosecution
 service.
