**Title:** Pasifika Education Centre: Funding Transfer

**Description:** This initiative provides for transfer of funding from Vote Tertiary Education to Vote Pacific Peoples for the Ministry for Pacific Peoples to support and monitor the Pasifika Education Centre's (PEC's) non-educational outputs from 1 October 2018 until the end of the 2019 academic year. This is because PEC's community-based Pacific language and cultural education and training activities align more closely with the role of the Ministry for Pacific Peoples than the functions of the Tertiary Education Commission.
