## Purpose of Report

- 1. Attached for your approval are the Terms of Reference, agreed by MSD and Treasury officials, for the review of parts of the Ministry of Social Development's operating baseline.
- 2. We also recommend that you refer these Terms of Reference to all other Ministers likely to be affected by this review.

### **Baseline Review**

- 3. The Minister of Finance and the Minister for Social Development have agreed to commission a review of the Ministry of Social Development's operating baseline, to be jointly conducted by the Treasury and MSD. It is scheduled to report in time for the Ministers' decisions to be included in Budget 2019.
- 4. The review is complementary to the Welfare Expert Advisory Group's review (WEAG), and the Terms of Reference make it clear that the areas covered by WEAG are out of scope, although there may be a few minor areas of overlap which will need to be managed carefully. The review will therefore focus on the approximately \$1.4 billion of spending on the core operational activity of MSD.
- 5. Depending on Ministers' decisions once the review has reported, it is possible that an agreed funding path for MSD's operations beyond Budget 2019 might emerge.
