Proposed Overseas Travel: Hon Grant Robertson

Portfolio **Sport and Recreation**

On 30 September 2019, Cabinet:

- 1 **authorised** the absence of Hon Grant Robertson from New Zealand, subject to leave from Parliament being secured, from 24 October to 3 November 2019 to travel to Tokyo, Japan
[1] for bilateral visits;
- 2 **agreed** that he be accompanied by one member of staff;
- 3 **approved** the estimated expenditure for the travel expenses of the Ministerial party as a charge to Vote: Internal Affairs (Members of the Executive – Travel);
- 4 **noted** that he will be accompanied in Japan by officials from Sport New Zealand and the Treasury, [1] whose travel costs will be met by their departments;
- 5 **noted** that he will also be accompanied in Japan by his husband, whose costs will be met by him personally;
- 6 **agreed** that in his absence:
 - 6.1 Hon Dr David Clark act as Minister of Finance;
 - 6.2 Hon Dr Megan Woods act as Minister Responsible for the Earthquake Commission;
 - 6.3 Hon Peeni Henare act as Minister for Sport and Recreation;
- 7 **noted** that leave from Parliament has been sought from the Party Whip.
