

Business Finance Guarantee Data

Key facts:

Changes enacted last year expanded and simplified the Business Finance Guarantee Scheme. In August 2020, key amendments to the scheme include the credit provided can now be used for capital investment, maximum loan size was increased to \$5 million and the loan term was extended to up to five years. While banks make their own lending decisions, the Government clarified that the Crown does not require a personal guarantee on lending under the BFGS. Since these changes were made, there has been a significant uptake of the Scheme. In December, scheme availability to 30 June 2021 was confirmed.

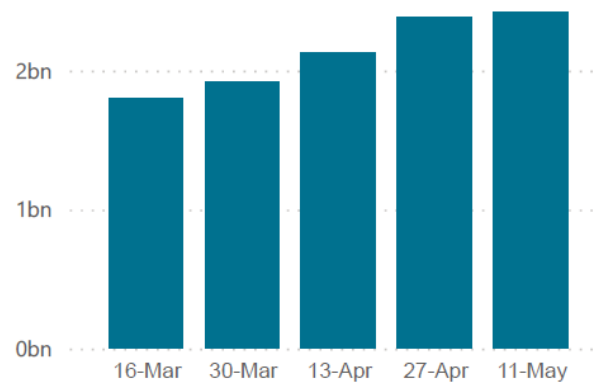

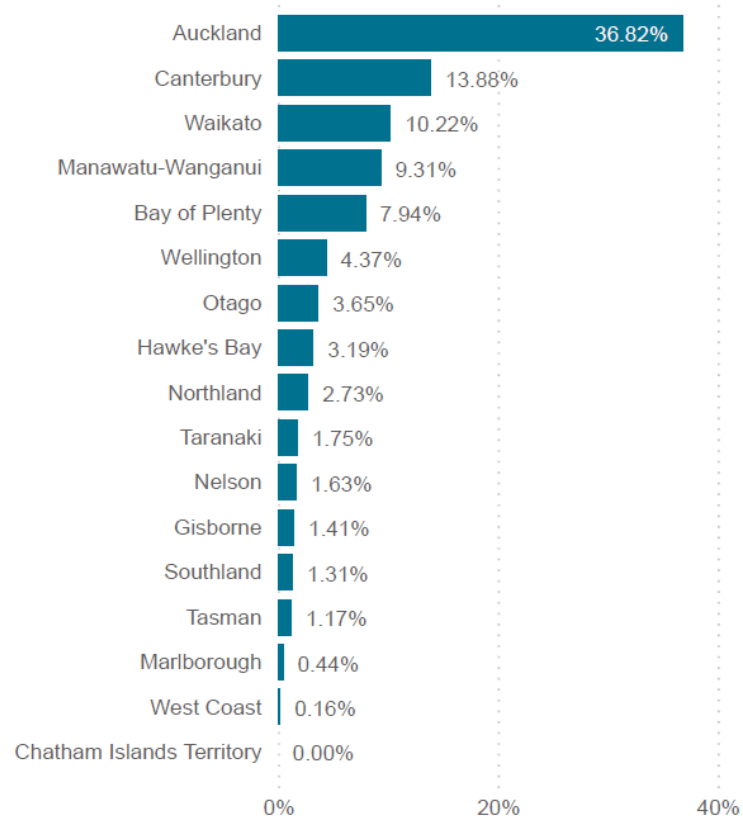
