- decreased funding of \$32.346 million for the reduction in the capital charge rate
- decreased funding of \$6.900 million transferred to other appropriations as the New Zealand Defence
 Force delivered isolation facilities and border services in support of the Government's response to the
 COVID-19 pandemic
- decreased funding of \$3.465 million for the transfer of operating funding to capital funding for personnel working on capital projects
- decreased funding of \$3.040 million for the transfer of funding to future years for the relocation of Service personnel to align with the more detailed introduction into service plan for the P-8A Poseidon aircraft for future air surveillance, and

 decreased funding of \$521,000 for operating funding transferred to capital funding for property maintenance that has resulted in asset improvement.

- decreased funding of \$72.400 million transferred to other appropriations as the New Zealand Defence Force delivered isolation facilities and border services in support of the Government's response to the COVID-19 pandemic
- decreased funding of \$23.044 million for the reduction in the capital charge rate
- decreased funding of \$5.518 million for the transfer of operating funding to capital funding for personnel working on capital projects, and
- decreased funding of \$844,000 for operating funding transferred to capital funding for property maintenance that has resulted in asset improvement.

This is partially offset by:

- increased funding of \$3.900 million for delivery of 'Shovel Ready' Defence Estate maintenance in the Southern Region during 2020/21
- increased funding of \$1.400 million for the transfer of funding from 2019/20 to 2020/21 for delays in a diverse range of Defence capability projects as a result of the COVID-19 pandemic

This category is limited to the costs of providing specialised support to all-of-government efforts to maintain security and stability in New Zealand's immediate neighbourhood including responses to events that impact on the safety and wellbeing of regional populations, as directed by the Government.

Reasons for Change in Appropriation

This appropriation decreased by \$2,000 to \$30.795 million for 2020/21. This decrease relates to decreased funding of \$2,000 for the reduction in the capital charge rate.

Policy Advice And Other Services For Veterans (M75) (A27)

Overarching Purpose Statement

The single overarching purpose of this appropriation is to provide policy advice and other support to Ministers in discharging their policy decision-making and other portfolio responsibilities, and the provision of services and payments to veterans.

Scope of Appropriation

Departmental Output Expenses

Administration Services

This category is limited to the provision of services to Ministers to enable them to discharge their portfolio (other than policy decision-making) responsibilities, the coordination of commemorations, the provision of administration services to relevant boards and committees and the administration of contracts for service for maintenance and development work carried out in Service Cemeteries.

Policy Advice

This category is limited to the provision of policy advice (including second opinion advice and contributions to policy advice led by other agencies) to support decision-making by Ministers on government policy matters relating to Veterans' Affairs.

Services and Payments to Veterans

This category is limited to the assessment, review and payment of entitlements and benefits (War Disablement Pensions and related concessions, and allowances and Surviving Spouse Pensions), the assessment and review of entitlement for burial in Service Cemeteries, the installation of ex-service memorials for eligible veterans, and the provision of case management for veterans and their families.

This appropriation increased by \$129,000 to \$10.424 million for 2020/21. This increase relates to increased funding of \$200,000 for Veterans' Health Connect. This was offset by decreased funding of \$71,000 for the reduction in the capital charge rate.

Protection of New Zealand and New Zealanders (M22) (A27)

Overarching Purpose Statement

The single overarching purpose of this appropriation is to protect New Zealand's sovereignty and provide security and other services for New Zealanders.

Scope of Appropriation

Departmental Output Expenses

Assistance to the Civil Power and Provision of a Public Service in Emergency Situations This category is limited to the costs of specialist military capabilities and Defence Force resources provided to the civil power in an emergency and for urgent work of national importance.

Defence International Engagement

This category is limited to the provision of services and utility of the Defence Force to support foreign policy objectives that strengthen security and avert conflict.

Defence Support to the Community

This category is limited to the costs of providing Defence Force resources for the betterment of the community at large and to inform the public's awareness of the proficiency and practice of the Armed Forces.

Military Assistance to Civil Authorities in Non-Emergency Situations

This category is limited to the costs of Defence Force resources, services and non-emergency assistance periodically provided to the Government and civil authorities.

Resource and Border Protection Operations

This category is limited to the sharing of information and provision of resources to support all-ofgovernment efforts to protect New Zealand's borders and offshore maritime interests.

Reasons for Change in Appropriation

This appropriation increased by \$81.755 million to \$605.249 million for 2020/21. This increase relates to:

- increased funding of \$97.900 million transferred to other appropriations as the New Zealand Defence Force delivered isolation facilities and border services in support of the Government's response to the COVID-19 pandemic
- increased funding of \$233,000 received from Service personnel for the provision of service housing and barracks, and
- increased funding of \$74,000 for a US Navy request for additional security costs in Singapore.

This increase is partially offset by:

- decreased funding of \$10.811 million for the reduction in the capital charge rate
- decreased funding of \$2.798 for the transfer of funding to 2020/21 for delivery of the Pacific Leaders Development programme
- decreased funding of \$1.667 million for the transfer of operating funding to capital funding for personnel working on capital projects
- decreased funding of \$760,000 for the transfer of funding to future years for the relocation of Service personnel to align with the more detailed introduction into service plan for the P-8A Poseidon aircraft
- decreased funding of \$245,000 for operating funding transferred to capital funding for property maintenance that has resulted in asset improvement, and
- decreased funding of \$171,000 for APEC 2021 security costs.
