Reasons for Change in Appropriation

This appropriation increased by \$1.161 million to \$35.150 million for 2020/21 due to:

- an in-principle expense transfer of \$1 million to enable ERO to complete its evaluation programme that was disrupted by COVID-19 in 2019/20
- an increase of \$200,000 due to higher levels of contractual services provided by ERO, and
- a decrease of \$39,000 due to a change in capital charge rate from 6% to 5% in 2020/21.
