# Aide Memoire: Fourth report on delivery of specific COVID-19 Response and Recovery Fund (CRRF) and Budget 2020 initiatives

#### **Background**

On 31 July 2020, the Treasury provided you and the Implementation Unit (IU) with a third report on the delivery progress of the 115 funded initiatives that the IU is tracking (T2020/2634 refers). This included initiatives funded through the COVID-19 Response and Recovery Fund (CRRF) and Budget 2020. All updates on progress since 31 July in the attached slide pack are based on information provided by the agencies responsible for the delivery of these initiatives.

This is the fourth progress report. You requested additional detail on NZ Trade and Enterprise (NZTE) spending and the Tourism Sector Recovery Fund. Due to changing priorities in the Treasury's response to COVID-19 alert levels, we have not been able to provide this analysis for the fourth report. However, we intend to include this analysis in a future report.

#### **Analysis**

The total allocated operating expenditure (OPEX) and capital expenditure (CAPEX) for all 115 initiatives is \$29,407.4 million OPEX and \$3,240.8 million CAPEX. These figures have not changed since the third report. Annex A provides an overview of these initiatives against the Government's broader investment, and key updates from the fourth report.

#### Fourth Report Highlights

Total spending to date has increased by \$783.5 million (+5.5%) since the first report to \$15,121.8 million (56.3% of total allocated OPEX for 2019/20 and 2020/21)<sup>1</sup>. This includes the increase in spending of the wage subsidy schemes and the administration costs for MSD/IR of \$563.4 million to a total of \$12,987.4 million in operating expenditure (81.5% of total allocated OPEX for 2019/20 and 2020/21).

Annex B provides detailed information on allocated and actual spending by portfolio. Five portfolios have no spending as at 10 August 2020. These are the Minister for Pacific Peoples (MPP), the Minister for Māori Development (TPK), the Minister for Courts (MoJ), the Minister for Ethnic Communities (Office of Ethnic Communities) and the Minister for Workplace Relations and Safety. Pacific Peoples in particular has five new initiatives that have not progressed. We will continue to monitor these portfolios. You may wish to direct the IU to investigate further.

The number of Ministerial announcements expected between now and the end of August are summarised below. Refer to Annex C for more detail on these announcements.

Annex D provides a list of initiatives identified in the previous reporting round that had no implementation plan and no spending to date, with a brief comment from Treasury vote teams in consultation with the relevant agency. By 11 August some of these initiatives had made progress either in spending or establishing an implementation plan. These initiatives have been noted in the comment. You can indicate whether you would like any further analysis on any of these initiatives that could be included in a future report.

The comments from the vote teams did not highlight any implementation issues that required follow up. Generally the comments indicate that agencies are progressing the initiatives and a delay in spending does not appear to be an indicator of any implementation issues.

Annex D includes a number of Ministry of Social Development (MSD) initiatives (including a number that are initiatives that are extending existing programmes) that you may wish to include in any discussions with Minister Sepuloni resulting from the comments on other MSD initiatives provided in Report 3.

#### Next steps and suggested follow-up

We are now over halfway through the IU reporting process. It may be useful to update your Ministerial colleagues on the IU's key observations. You could also restate expectations from your letter of 2 June 2020 around regular monitoring and reporting on the implementation progress of these initiatives particularly because a number of initiatives still do not have implementation plans. We can support the IU in drafting a letter.

We suggest you provide feedback on the slide pack and indicate what initiatives or areas you would like further reporting on, or no longer wish to monitor. In addition, please indicate in Annex D if there are any initiatives in the minimal progress category that you would like further investigation or comment on.

We intend to report to you and the IU next on 28 August 2020. This report is likely to include, as requested, further detail on NZTE, Tourism and the Education portfolio. The following reporting will include analysis on the initiatives being implemented by the Department of Conservation.
