# Aide Memoire: Fifth report on delivery of specific COVID-19 Response and Recovery Fund (CRRF) and Budget 2020 initiatives

#### **Background**

On 14 August 2020, the Treasury provided you and the Implementation Unit (IU) with a fourth report on the delivery progress of the 115 funded initiatives that the IU is tracking (T2020/2831 refers). This included initiatives funded through the COVID-19 Response and Recovery Fund (CRRF) and Budget 2020. All updates on progress since 14 August in the attached slide pack are based on information provided by the agencies responsible for the delivery of these initiatives.

This is the fifth progress report. You requested additional detail on NZ Trade and Enterprise (NZTE) spending, the Tourism Sector Recovery Fund, the Education and Conservation portfolios. Due to changing priorities in the Treasury's response to COVID-19 alert levels, we have not been able to provide this analysis for the fifth report. However, we intend to include this analysis in a future report.

#### Overview

For the fifth reporting cycle we asked agencies to focus on the following:

- Being clearer on the outcomes to be achieved from the initiative and how delivery is tracking towards delivering these outcomes. This includes specifying what the funding is purchasing for example FTEs, programme places or services from third parties:
- Ensuring the expenditure information is accurate particularly for initiatives reporting implementation progress elsewhere;
- For initiatives with no (or under development implementation) plans, indicating when implementation plans are expected.

In addition to the updates provided by agencies in the slide pack, the fifth report includes the following analysis:

- Overview of Implementation Unit initiatives Annex A
- Allocated and actual spending by portfolio (as at 24 August 2020) Annex B

#### **Analysis**

The total allocated operating expenditure (OPEX) and capital expenditure (CAPEX) for all 115 initiatives is \$29,407.4 million OPEX and \$3,240.8 million CAPEX. Annex A provides an overview of these initiatives against the Government's broader investment, and key updates from the fifth report.

#### Fifth Report Highlights

#### Reporting Changes

We have made a number of changes to the information included in the slides. In report 5, we requested agencies to provide greater clarity on the translation of the delivery of their initiatives to the outcomes expected. We have reflected this deliberate shift in the attached report. This includes highlighting expected outcomes per initiative, whether or not they have been achieved, and past or upcoming outputs/milestones. Additionally we have added a "Delivery Status" field to the reporting for each initiative to indicate the stage of delivery for each initiative. Annex D sets out the status for each initiative and we have included a summary below.

#### **Key Indicators**

Total spending to date has increased by \$957.6 million (+6.67%) since the first report to \$15,296 million (56.9% of total allocated OPEX for 2019/20 and 2020/21)¹. This includes the increase in spending of the wage subsidy schemes and the administration costs for MSD/IR of \$706.7 million to a total of \$13,130.7 million in operating expenditure (82.4% of total allocated OPEX for 2019/20 and 2020/21). Since Report 4 there has been \$174m additional spending (including \$143.3 million of additional wage subsidy spending).

Of the 115 tracked initiatives, 43 initiatives have nil spend to date. 28 initiatives are existing programmes and 15 are new programmes. Of the 28 existing programmes – 9 initiatives are reporting that they have no implementation plans and no external reporting processes in place. Of the 15 new programmes – 4 initiatives are reporting that they have no implementation plans and no external reporting processes in place. Implementation plans and reporting processes are key early steps in the delivery process.

Below is a list of initiatives that are reporting no spending to date, no implementation plan and no reporting processes in place. We recommend that you write to the responsible Ministers to follow up on the delivery of these initiatives with the exception of the Minister of Education as we are expecting a significant delivery update from the Ministry of Education as part of the next IU report. We have provided the IU with a draft letter for this purpose:

There has also been an adjustment of \$57.3m to the Tourism Sector Recovery Fund spending to reflect the actual drawn down spend to date. Previous figures reflected funding committed (\$78.7m).

We suggest you provide feedback on the slide pack and indicate what initiatives or areas you would like further reporting on, or no longer wish to monitor.


