Approving the New Zealand Sovereign Green Bond Framework

Portfolio Finance

On 31 August 2022, the Cabinet Economic Development Committee (DEV):

- noted that on 1 November 2021, the Cabinet Business Committee agreed to the establishment of a sovereign Green Bond Programme, which will allow the Crown to issue New Zealand Government Green Bonds [CBC-21-MIN-0119];
- agreed to the New Zealand Sovereign Green Bond Framework (the Framework), attached as Annex 1 to the paper under DEV-22-SUB-0204, which outlines the design and operations of the New Zealand Sovereign Green Bond Programme;
- noted that the Framework covers a broad range of the government expenditures that deliver the government's comprehensive climate and environmental priorities;
- **authorised** the Minister of Finance to make minor and technical amendments to the Framework;
- 5 **noted** that the Treasury will publish the final Framework in September 2022;
- 6 **noted** that New Zealand Debt Management intends to issue New Zealand's first Sovereign Green Bonds before the end of 2022, subject to market conditions;
- 7 **noted** that Green Bonds, alongside standard Nominal Bonds and Inflation-Indexed Bonds, are expected to be an important and enduring part of the New Zealand Government Bond portfolio;
- **agreed** that each agency with current or future expenditure in the New Zealand Sovereign Green Bond Programme provide the Treasury with:
 - 8.1 information about potential new expenditures that may be eligible for inclusion in the Programme;
 - 8.2 quarterly financial information on each expenditure included in the Programme;
 - annual impact (outputs and outcomes) information on each expenditure included in the Programme, commencing in 2024;
 - 8.4 information on material risks and issues on each expenditure included in the Programme;

- directed the Treasury, in consultation with relevant agencies, to develop the specific monitoring and reporting requirements for expenditures in the Programme;
- invited the Minister of Finance to report back to DEV on the progress and key achievements of the Programme in late 2023.
