Notes on Schedule to Notice of Claim (please read before completing this form)

- Why do I need to provide all this information to the Crown when making my claim? The Crown needs this information to process your claim properly. For instance, the Crown needs to know how to contact you and where to make payment.
- Why do I need to provide details of my identity?

To make sure the Crown makes payment to the right person. In addition the Retail Deposit Guarantee Scheme only operates for the benefit of New Zealanders or for non New Zealanders that are resident here for tax purposes.

- Why does the Crown need my IRD number and details of my Resident Withholding Tax rate?
 If you are a joint holder, the Crown needs this information to make sure that the Crown makes the correct deductions for tax when the Crown makes payment to you. This is no different from the tax deductions made by Mascot when making interest payments to you.
- Who is a Related Party?

- How will payment be made?
