[SRES attendees arrived at 12 noon, introductions to [23] (member of the SRES Legal Team who issued the first Internal Review Decision under the Package Review Process) followed by 15-minute break for lunch]

- 6. General matters
  - 6.1. Review of matters discussed above
    - 6.1.1. IOC referred to correspondence received 14 September 2022 from GCA Lawyers expressing concern about the approach SRES is taking in relation to certain other costs in contingency calculations for Package offers.

Having discussed this and sought information from both SRES and the Crown, IOC members advised that they are now satisfied that the approach SRES is taking is in accordance with the Package principles and processes agreed between Southern Response and the Crown.

Having regard to the Committee's mandate to consider the interests of affected policyholders, the Committee is satisfied that the approach SRES is taking is also consistent with the Package principle of putting those who cash-settled with SRES before 1 October 2014 in a similar position to those who settled after that date.

- 6.1.2. SRES confirm that the suggestion made in the KPMG report relating to closing claims has been included in that process (which is now documented). SRES will provide a new suite of Package related processes to IOC and the Secretary will update the Diligent resource centre accordingly.
- 6.1.3. **SRES will provide** its internal Quality Assurance report before the February 2023 meeting.
- 6.1.4. New OOS identity requirements will be implemented (initially on a trial basis) once staff training and system changes are complete. The NZ Police fraud training for staff is the first step and this is scheduled for next week.
- 6.1.5. SRES will check and confirm the over 90 days \$ value from November's papers.
- 6.1.6. SRES responded to IOC query re MVP claims forming a large proportion of over-cap clients yet to be contacted. These claims are more complex and also more likely to result in no payment being due under the Package. A smaller team is now working in this area as most over-cap claims have been settled.
- 6.1.7. SRES provided an update on the OOS contact project. Once the High Court has approved the changes to the SRES website, OOS clients will be contacted in tranches to control workflow. SRGC will provide IOC with a copy of the relevant documents when filed with the High Court.
