# Agenda items

1. **Welcome Apologies and quorum –** The Chair welcomed attendees, noted the quorum was met and acknowledged an apology for lateness from NK.

- 3. Minutes of previous meeting The November 2023 minutes were approved.
- 4. Matters arising from Minutes -
  - 4.1. November Action items reviewed. The Comments email inbox will be transferred from DA to NA who will forward any emails to DA.
- 5. Other general business
  - 5.1. **Information Analysis Checklist reviewed –** The Committee reviewed items on the checklist, clarifying as necessary.
  - 5.2. **Review SRES papers** noted various matters to be checked/confirmed with SRES.

- 6. General matters including any arising from 5.2 above
  - 6.1. General discussion around various issues.
  - 6.2. New Ministers with responsibility for SRES and IOC are not yet formally advised. The Crown Report will be sent to the responsible Minister(s) once advised.
  - 6.3. Package Review Process no new requests in this period.

# 7. Company update –

- 7.1. **Legal landscape** SRGC updated the IOC on recent legal proceedings. Recent Court decisions were discussed. On 23 November 2023 the High Court rejected Mr Ressels' application for representative class action status for his court proceeding against Southern Response (*Ressels v Southern Response Earthquake Services Ltd* [2023] NZHC 3344). On 4 December 2023 the Court of Appeal rejected Mr Ressels' application for leave to appeal against the High Court's 21 February 2023 decision denying Mr Ressels second plaintiff and representative status in Mr Sneesby's court proceeding against Southern Response (*Ressels v Southern Response Earthquake Services Ltd* [2023] NZCA 614). The Committee noted a related media report.
- 7.2. Current Legal issues and Discretionary issues Review of the Discretionary Decisions register: recent Discretionary Decisions were explained and discussed.
- 7.3. **Operational progress** Both overcap and Out of Scope (OOS) applications are ahead of forecast in terms of claims settled. SRUM noted the process for OOS applications is working well.
- 7.4 **Customer Survey** SRES management reported the results of the November 2023 Customer Survey about the experiences of Out of Scope (OOS) settlements. Results were positive and 80% of respondents rated the experience "good". The average overall experience was rated 8.9/10.
